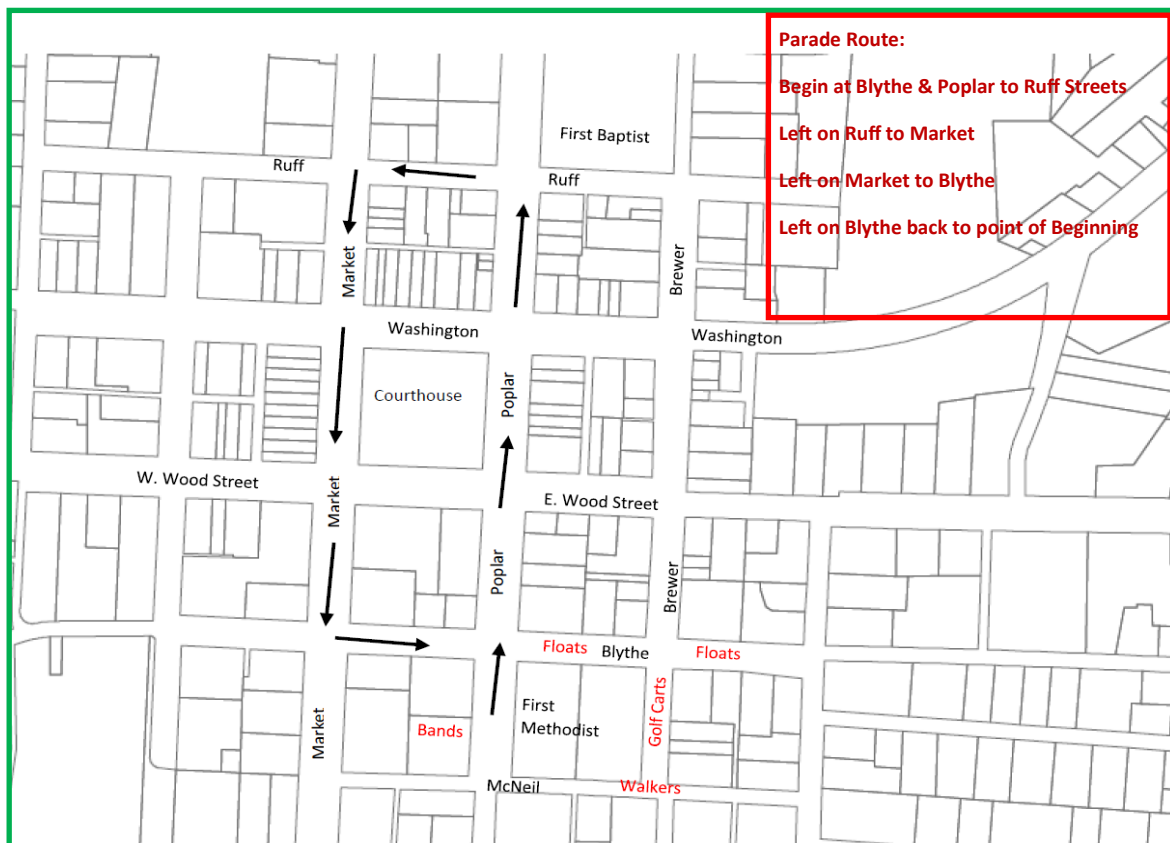

**Parade Rules:**

1. Trailers must be no longer than 20 feet, can be non-motorized or may be pulled by motorized vehicle.
2. Commercial entries will be allowed if they are decorated for Christmas—not just driving thru to advertise. All vehicles must be decorated except for classic or vintage vehicles.
3. You may ride in golf carts, an ATV or Small Tractor (20 hp or less) or walk/march.
4. You must be at least 16 years of age to operate a motor vehicle, golf cart, small tractor or ATV. Be prepared to show proof of insurance and driver's license prior to parade.
5. No objects (candy, gum, etc) thrown to spectators – items can be handed out only at sidelines
6. All animals must be properly restrained at all times and entrant is responsible for animal waste.
7. Must be at the designated street or lot for your entry type (See Attached Map) no later than 4:15 p.m.
8. Judging will take place prior to the parade at 4:30 pm, entries must be present and fully decorated with lights lit for judging to be considered. Winners will be announced during the parade.
9. Entries are not allowed to have a Santa Claus or Mrs. Claus associated with their entry. However, elves are welcome. THE Santa Claus will be riding on a fire truck. (Don't want the little ones to be confused by two Santas.)
10. Marching units must consider carrying glow sticks, glow in the dark shirts, lights or something that will illuminate at night.
11. *DPA RESERVES THE RIGHT TO REFUSE/SCREEN ANY ENTRIES.*
